Assumption of Responsibility and Risk

Martial Arts is a potentially dangerous activity. Bumps, bruises, scrapes, and soreness, are possible and some students will encounter this sort of minor injury from time to time in their training. More serious injuries are possible, including sprains, strains, twists, cramps and injuries of similar magnitude and students can expect to encounter these injuries infrequently. The possibility of more serious injury exist, including fractured bones, broken bones, torn ligaments, though not all students encounter such serious injuries. There remains, despite safety precautions, the remote possibility of crippling death. This is not expected in any class, workshop, seminar or any other activity East Coast Martial Arts provides, however there is always a risk.

I understand the above statement of risk, and I understand the rights and responsibilities for my own safety (or the safety of my child), understanding and accepting the risk involved with martial arts training. Even if the instructor has informed me that no serious injury has ever happened in this school or with any of the instructors, I understand that this does not mean that there is no possibility of harm. By assuming this risk, I completely absolve all instructors, staff, guests, students, landlord, management companies, and any and all other parties of liability for my harm, unless intentionally caused in criminal conduct.
